# BRIEF ON HIGHWAYS CONSTRUCTION AND REHABILITATION DEPARTMENT, NORTH WEST ZONE

#### **INTRODUCTION**

The Highways North West is one of the six (6) Zones in the Department of Highways Construction & Rehabilitation responsible for the overall management of highway operations in the seven (7) States of the North West Geopolitical zone of the country:

- a. Jigawa
- b. Kaduna
- c. Kano
- d. Katsina
- e. Kebbi
- f. Sokoto
- g. Zamfara

The Zone is headed by a Director with two (2) No. Deputy Directors, five (5) No.Engineers, three (3) No.Technical officers and seven (7) No.Administrative/

Secretarial staff, as supporting staff in the Zonal Headquarters. The nominal roll of the staff in the Zone is at page 7, please.

The total length of Federal Roads in the Zone is 6,166.80Km out of which 4,374.30Km are of asphaltic concrete surfacing, 1,256.50Km are of surface dressed while the remaining 536Km are earth road.

There are forty (40) on-going highway projects in the Zone which are at various level of completion.

The objectives of the Zone are:-

- i. To ensure effective and efficient management of federal roads in the zone;
- To coordinate, supervise and execute federal road developmentprogrammes and rehabilitation of projects in the zone; and
- iii. To maintain and keep data base for all federal roads in the zone.
- Process Interim Statements and recommend certification and payment for works executed by contractors for highway contracts in the Zone;
- v. Ensure project implementation in line with budgetary provision.
- vi. Initiate and formulate road development and improvement programs in the zone in liaison with Highway Development & Planning Department;
- vii. Oversee activities of all Federal Controller of Works, Project Supervisors/Consultants in the zone in liaison with the relevant departments;

- Proper supervision and management of all Highways Projects, projects Staff/ Contractor and supervising consultants in the zone in liaison with the relevant departments;
- ii. Any other function as may be assigned by the Permanent Secretary.

## FEDERAL CONTROLLER OF WORKS/ENGINEER'S REPRESENTATIVE (FCW/ER)

The Federal Controller of Works heads the Federal Ministry of Power, Works and Housing (Works Sector)Field Headquarters in the State. They also function as Engineer's Representative on highway projects with Projects Supervisors assigned on each of the projects reporting to the Engineer's Representative. The ER report directly to the Zonal Director on their duties.

The main duties of Project Supervisors on road projects include and not limited to the following:

- i. Watch and supervise the works and to test and examine any materials to be used, or workmanship employed in connection with the works
- ii. To ensure that the works are delivered as designed and in accordance with the specifications given for the works.
- iii. Preparation of monthly progress reports
- iv. Carries out joint measurement with contractor of all works executed on site.
  - iii. Any other duties that may be assigned by the ER and Zonal Director.

# <u>PROJECT BRIEF FOR THE REHABILITATION OF HADEJIA – NGURU ROAD PHASE II</u> (KIRIKASAMMA – NGURU), CONTRACT No.6072 IN JIGAWA STATE AS AT 5<sup>TH</sup> <u>FEBRUARY, 2019.</u>

#### **PROJECT DESCRIPTION:**

The road contract starts from Km 40 + 000 (Kirikasama) and ends at km 72 + 750 (Nguru) and was awarded under Phase II while the Phase I KM 0 + 000 (Hadejia) to KM 40 + 000(Kirikasama) was awarded to Messrs Setraco (Nig) Ltd and had since been completed and handed over by the contractor.

#### **SCOPE OF WORKS:**

The scope of works involve the scarification of failed pavement up to formation level, laying of 200mm laterite sub-base and 200mm crushed stone base, 60mm asphaltic concrete binder course and 40mm asphaltic concrete wearing course, reinstatement of eroded road shoulders.

#### **PROJECT DESCRIPTION:**

Ajingi – Jahun – Kafin Hausa road (Route 333) continues to Gaya and Wudil in Kano State. The road connectsJama'are – Maiduguri road at Gaya and joins the Kano – Kari road in Wudil. It also connects Hadejia – Gamayin – Bulangu road (Route 70) at Gamayin. The road is an important link connecting commercial center thus enhancing movement of Agricultural produce and facilitating commerce. It is 106km long and consists of 7.3m wide asphaltic concrete carriageway with 2.75m width surface dressed shoulders on either sides.

#### **SCOPE OF WORKS:**

The works involve rehabilitation of failed sections of the road by executing the following works; scarification of failed pavement up to formation level, laying of 200mm laterite sub-base and base, 60mm asphaltic concrete binder and 40mm asphaltic concrete wearing course, cutting and patching of potholes, crack sealing, reinstatement of eroded road shoulders, lined drains, concrete kerbs, kilometre posts, road signs and road markings.

#### **PROJECT DESCRIPTION:**

The Tsakuwaran – Galambi road is a 14.072km length road that links Tsakuwaran – Nasarawa – LarkanKuyungo – Chadako – Galambi in Jigawa State. The road is on flat terrain and the soil type is predominantly sandy. The objective of constructing this road is to make it motorable, reduce travel time and also provide access to major towns. The road is to be constructed to double lane of 7.3m wide carriageway width and 1.50m wide shoulders on both sides.

#### **SCOPE OF WORKS:**

The scope of works include; Site clearance on either side of the carriageway, provision of culverts and lined drains, provision of stone pitching and grassing, provision and laying of 150mm thick laterite sub-base and base courses, provision and laying of prime coat using MCO/MCI, provision of first and second coat surface dressing on carriageway and shoulders and provision of kilometer post and lane marking/signs.
